This Season Pass Holder Reservation Form and Agreement (the “Agreement”) is by and between the undersigned Season Pass Holder, as more particularly defined above, and Sarasota Saddle & Sail, LLC (“Sarasota Polo Club”). The undersigned parties hereby agree as follows:

- ☐ I hereby apply to be a Season Pass Holder in the VIP Champagne Lounge at the Sarasota Polo Club for the 2027 Season of Sarasota Polo. I agree to abide by the rules and regulations of the Sarasota Polo Club.
- ☐ I understand that this ticket price does not include food and beverage. These are to be purchased at an additional expense to me while I am on-site.
- ☐ I agree to consume alcohol responsibly and to be mindful of my personal limits and those of my guests. I understand that if I or my guests appear intoxicated, we may be asked to leave the event.
- ☐ I understand that I do not automatically receive my ticket for each match. I am responsible for providing notice to the Sarasota Polo Club each week by the Monday prior to the event, letting them know whether I will be in attendance or not for each match, so that staff can prepare accordingly for my presence or absence.
- ☐ I understand that, upon arrival, my ticket(s) must be presented at the South Entrance off of Lorraine Road by myself and/or my guests. My ticket(s) may not be used for admission at the North entrance. I understand that entry for myself and/or my guests will not be permitted without the presentation of a ticket
- ☐ I understand that, during play, myself and my guests must remain behind the red safety line for our safety.
- ☐ I understand that each ticket grants entry and automatically enrolls the holder as a temporary, single-day member of the Sarasota Polo Club for the specified event dates only. By purchasing a Season Pass and entering the club premises, the Season Pass Holder agrees to strictly adhere to all Sarasota Polo Club rules, bylaws, and player/spectator codes of conduct.

- ☐ **Alcohol Policy:** Season Pass Holder acknowledges that it has read, agreed to, and executed the Alcohol Policy, Indemnification and Waiver Agreement attached hereto, and that such agreement is a material inducement to your partnership with the Sarasota Polo Club.
- ☐ **Rain Out & Refund Policy:**
VIP Champagne Lounge Season Passes are non-refundable, including canceled matches due to weather. Like other outdoor sporting events, polo is subject to weather. The Sarasota Polo Club reserves the right to cancel a match if weather conditions are deemed too dangerous for play. Notices will be posted on our social media pages (Facebook and Instagram) if the Sarasota Polo Club staff makes this decision for a particular event. All Season Pass Holders for that date will also be notified via email. Rain checks are not given for season passes.
- ☐ **Release of Liability Statement:**
By purchasing a VIP Champagne Lounge Season Pass to the Sarasota Polo Club and/or entering the grounds of the Sarasota Polo Club, I agree that I assume all risk and danger incidental to the game of polo – including balls, mallets, and horses leaving the field. I acknowledge that I release the Sarasota Polo Club and its members, sponsors and players from all claims of liability.
- ☐ **Wind Policy:**
On windy days, the Sarasota Polo Club reserves the right to not allow the use of 10×10 tents, umbrellas, and sail shades to ensure the safety of our players, horses and spectators. Notices will be posted at the entrances, as well as on our social media pages (Facebook and Instagram) if the Sarasota Polo Club staff makes this decision for a particular event. All Season Pass Holders for that date will also be notified via email. We appreciate your understanding and cooperation as Mother Nature continues to keep us on our toes.

Alcohol Policy, Indemnification and Waiver Agreement

This Agreement is entered into by and between Sarasota Polo Club ("Club") and the undersigned individual(s) ("Season Pass Holder(s)") as a condition of attendance at any Club-sponsored event where alcoholic beverages are present, served, or consumed.

Alcohol Policy

1. **Alcohol Distribution.** Alcoholic beverages may be made available at certain Club events either by the Club, its staff, or approved third-party vendors. The Club does not permit outside alcohol to be brought anywhere within the grounds of the Sarasota Polo Club (the "Property").

Age Restriction. Only individuals who are 21 years of age or older may consume alcoholic beverages on Club premises or at Club-sponsored events, regardless of location. The Club reserves the right to request valid government-issued identification.

Responsible Consumption. Season Pass Holders and guests are expected to consume alcoholic beverages responsibly. The Club reserves the right to deny service or request that any individual cease consumption if, in the sole judgment of Club management or staff, the individual appears intoxicated or poses a risk to themselves or others.

2. **No Alcohol to Minors.** Providing alcohol to minors (anyone under the age of 21) is strictly prohibited and will result in immediate removal from the premises and potential revocation of season tickets.
3. The Season Pass Holder acknowledges that participation in events involving alcohol carries inherent risks, including but not limited to physical or mental impairment, illness, injury, or property damage. The Season Pass Holder voluntarily accepts full responsibility for these risks, whether caused by their own actions or those of others.

Waiver of Liability and Indemnification

4. To the fullest extent permitted by law, the Season Pass Holder hereby waives, releases, and discharges the Club, its owners, officers, directors, employees, agents, volunteers, and affiliates (collectively, the “Released Parties”) from any and all liability, claims, demands, actions, or causes of action arising out of or related to injury, illness, death, or property damage resulting from or in any way connected with the consumption, distribution, or presence of alcohol at any Club event. The Season Pass Holder, as well as Season Pass Holder’s guests and invitees, agree to indemnify, defend, and hold harmless the Club, its officers, directors, members, employees, agents, and affiliates (collectively, the “Indemnified Parties”) from and against any and all claims, liabilities, damages, losses, costs, and expenses (including reasonable attorneys’ fees) arising out of or related to Season Pass Holder’s, and Season Pass Holder’s guests and invitees, participation in any event held on the Property, including but not limited to claims arising from or related to the actual or alleged distribution, service, provision, or consumption of alcoholic beverages on the Property; any violation of this Alcohol Policy or applicable laws relating to alcohol; and any claim brought by a third party as a result of the Season Pass Holder’s conduct in relation to alcohol at a Club event.

Acknowledgment and Agreement

5. By signing below, the Season Pass Holder acknowledges that they have read, understood, and agreed to the terms of this Alcohol Policy, Indemnification and Waiver Agreement. The Season Pass Holder further agrees that this Agreement shall remain in full force and effect for all Club events they attend unless otherwise revoked in writing by the Club.
